Listed below is the fee structure for Civil Process Fees, pursuant to §§ 30-1-104, 105, 105.5, 106, 107 and 116 C.R.S., as amended in accordance with House Bill 10-1057, and approved by the Clear Creek County Board of Commissioners under resolution number R-10-81, August 11, 2010, and resolution number R-10-95, August 25, 2010. These resolutions shall take effect September 01, 2010.

It is the customer's responsibility to inform the Sheriff's Office Civil Division of the number of days to be attempted for each paper to be served.

PREPAYMENT OF SERVICE FEE PLUS MILEAGE FEE FOR NUMBER OF DAYS TO ATTEMPT SERVICE IS REQUIRED IN ADVANCE per §30-1-116. If service is executed in less days, a refund will be returned to the customer with the proof of service.
